Trogdon, Jr., R.L.S., dated December 20, 1973, which plat is recorded in the RMC Office of Beaufort County, South Carolina in Plat Book 23 at Page 18, dated February 9, 1979, and revised in March 29, 1979, which plat is recorded in the RMC Office of Beaufort County, South Carolina in Plat Book 27 at Page 172, dated December 15, 1978, which plat is recorded in the RMC Office of Beaufort County, South Carolina in Plat Book 27 at Page 160, and dated May 19, 1986, and revised on October 29, 1987, and June 16, 1988, which plat is recorded in the RMC Office of Beaufort County, South Carolina in Plat Book 35 at Page 277.

This conveyance is made by the Grantors and accepted by the Grantee subject to a power line easement to S.C. Electric and Gas Company which is shown on the above referred to plat.
